- 4. The engagement will be purely on contractual basis, non-regular & co-terminus under ICAR-CTRI, Rajahmundry. The incumbent shall not have any claim for regular appointment under ICAR-CTRI/or ICAR or any further contractual engagement on termination of the scheme. The services of the incumbent shall stand terminated automatically on expiry of the period given in the offer letter.
- 5. The tenure of engagement will be initially for a period of one year from the date of engagement. Subject to extension/continuation/approval of terms of the scheme, the engagement of the above positions may be further extended for 1 more year OR as decided by the competent authority subject to satisfactory performance of selected candidate, work requirement and budget allocation.
- 6. The selected candidate shall have no legal right to claim regularization by absorption or otherwise or against any regular post or any further continued engagement on termination of the scheme, in the ICAR-CTRI and/or ICAR.
